



Waiver of Liability and Photo Release for T3MA of Bellevue, LLC Use

PLEASE READ THIS AGREEMENT CAREFULLY AND BE CERTAIN YOU UNDERSTAND THE IMPLICATIONS OF SIGNING THIS DOCUMENT BEFORE INITIALING OR SIGNING. IT CONTAINS IMPORTANT INFORMATION REGARDING YOUR RIGHTS AND CONTAINS A DISPUTE RESOLUTION CLAUSE. BY INITIALING AND SIGNING THIS AGREEMENT, YOU AGREE THAT YOU HAVE READ THIS AGREEMENT AND UNDERSTAND EACH PROVISION CONTAINED IN THE AGREEMENT.

In consideration of receiving martial arts instruction from T3MA of Bellevue, LLC (the "School") and Top 3 Martial Arts, LLC (and its shareholders, owners, employees, agents, and/or assigns) hereinafter collectively referred to as "T3"), I agree to the following:

I, _____ (print name of student) as a student of School and/or as a parent or guardian of a student of School have been fully informed of the inherent risks, associated with getting martial arts instruction and training. I fully understand that these risks, known and unknown, can lead to injury, illness, or even death. Having been informed of the potential risks associated with martial arts instruction and training, I still wish to proceed with the instruction and training and I freely accept and expressly assume any and all risks that may arise from the instruction and training.

I hereby acknowledge my responsibility in communicating any physical and psychological concerns that might conflict with participation in the instruction and training. I acknowledge that I am physically fit and mentally capable of performing the physical activity I choose to participate in. It is understood that before participating in any fitness activity, my doctor must first be consulted for personal risks/benefits.

The School has given me the full opportunity to ask any and all questions about the instruction and training and all of my questions have been answered to my total satisfaction. I agree to inspect the facilities, equipment and pairings prior to participation. I will immediately inform the School if I believe that anything is unsafe or beyond my capability and refuse to participate.

I WAIVE, RELEASE AND HOLD HARMLESS to the fullest extent permitted by law the School and T3 from all liability whatsoever, for any and all claims or causes of action that I, my estate, heirs, executors or assigns may have for personal injury or otherwise, including any direct and/or consequential damages, which result or arise from the instruction and training, whether caused by the negligence or fault of either the School, T3 or otherwise.

I do hereby give the School, its assigns, licensees, and legal representatives the irrevocable right to use my name, video, picture, portrait, or photograph in all forms and media and in all manners, including composite, for advertising, for publication or any other lawful purposes, and I waive any right to inspect or approve the finished product, including written copy, which may be created in connection therewith.
